READING: Literary Liaisons (LA's) evaluate submissions for the magazine, they will read and interpret a variety of texts: poetry, fiction, creative nonfiction, and visual arts: fine art, photography, comics, illustrated narratives, and hybrid work. Close, critical reading requires LA's to appreciate each piece's literary merits and to determine its level of fit within the vision of the magazine. In this practice, they will engage in the following skills:

WRITING & REASONING: During genre meetings as well as in written feedback via our submission management program, Submittable, LAs will discuss merits of submissions and areas for literary development. In these discussions, they will be asked to support their voting decisions and provide a rationale for accepting or rejecting submitted work; particularly if the group needs to work to reach a consensus about the inclusion/exclusion of any piece.

Additionally, LAs will learn how to write personalized rejection letters wherein they will

practice articulating constructive, encouraging feedback for submitted work that we could not place in our current issue. In these exercises, they will engage in the following skills:

<u>Creative Classroom Workshops + Peer Workshops</u>

During Creative Classroom Generative Writing Workshops, LAs and community participants will discuss a variety of craft aspects as well as participate in generative writing exercises under the expert guidance of a visiting teaching artist.

During Peer Workshops, LAs will work in collaboration with Assistant Genre Editors (AGEds) to provide/receive constructive feedback for peer works generated during the Creative Classroom workshops and compose a short critique of each workshop piece. This allows LALAs to develop revision skills by learning from feedback applied to their work as well as the work of their peers.
